In the words of the Misamis University College of Law OIC Dean, Atty. Cleo Marjo Cabanilla, it is the annual flagship event for the legal sector. The Philippine National Law Week Celebration is usually celebrated amongst students, teachers and peers face to face. However, the threat of the current health crisis has forced a substantial number of organizations, institutions and people to adapt to the new normalcy in terms of gatherings. Despite, the situation, the annual launching of the Philippine National Law Week for Misamis University kicked-off without a hitch.

September 20. 2021 catapulted the celebration with a Talk Show: Kasavuran: Eleksyon Atong Hisgutan, which allowed law students and professors to share their thoughts on election. The event happened via Zoom and Facebook live, hosted by Ms. Steffi Dawn Ilagan and Mr. Reyel Galario, who are both sophomore law students of Misamis University-College of Law. The same was also attended by the OIC Dean. law professors, and law students from various year levels.

To highlight the core topic of said event, here are some of the questions and answers which stood out during that night.

In the question "Why do you vote?" Ms. Hannilore Villamor-Legaspi said "I vote because it is the most basic and possibly the most important act of citizenship in the electoral process. I vote because it is my right and duty to choose my leader."

That is why voting good leaders to be our representative is imperative as representation is key to a good country. Furthermore. the importance of practicing our right to suffrage is to determine the future of our country. And to determine whether we make it or break it as a nation." Mr. Alfred Cañete encouraged us to vote using the quote by Malala Yousafzai "When the whole world is silent. even one voice becomes powerful."

This, reminds us that our vote is the key to choosing leaders whom we think could bring positive change to our society.

Mr. Nehemiah Montecillo reminded the audience to choose the candidate that is closest to their hearts: a candidate whose love for the service of the people is seen. who thinks of the future of our family, of our children, and of our nation. Ms. Jihan Banding also emphasized that it is very important that the youth of our nation must not be indifferent to our situation. She further stated that change comes from us and reminded us that if we do not do anything to change our situation. nothing would happen. Atty. Ivy Manago elucidated an inspiring talk. encouraging the students to really vote. She said that even if our candidate doesn't win, still, it's important to vote. She reminded us to choose leaders whose integrity are intact and their sincere in doing responsibility. Generally, leaders who have humility. because a leader that is understands the humble plight of the people. Another professor in the person of Atty. Lulu Enerio likewise encouraged the audience to vote as it is very important to do so.
